GROUP PARTICIPATION APPLICATION

Rules and Regulations: (to be strictly followed)

• All stands will have one Captain of the group. The captain has to make the payment on behalf of the stand and contract will be raised on the name of the captain. DWTC will not raise different bills or invoices or contract for each artist.

- Fascia and Name board can be printed showing the names of the 3 artists and it can be displayed in the stand after filling the facias board form
- A curator will be appointed and all 3 artists have to follow the rules and regulations shared by the curator in terms of display of space. The group is formed and artist are allowed to participate in the group only if they agree to follow the instructions by the appointed curator irrespective of if the payment is made by all 3 artists.
- Selection of which artist on which wall is supposed to be done by the group mutually and if they fail to do so curator will help the group in their display plan
- If any artist wants to change the group member they can add a new member by informing the curator and taking the approval and increase their stand space. In case if one artist leaves and at the last-minute group of 3 is now group of 2. It is the responsibility of the Captain to pay the full amount else they will not be allowed to participate.
- Captain or any other artist cannot cross sell the space to any 4th artist for any benefit or just for helping or favor. Artist more than 3 is not allowed in a stand as per the format given at the end of the number of artists allowed in a stand.
- A captain cannot charge more than what DWTC is charging for the stand i.e contribution of each artist for each wall should be same and no one should end up paying extra amount.
- We cannot have 2 or more different flags on the facia of the stand hence either it will be UAE flag or No Flag or if all artists are of the same country they can have 1 common flag on stand.
- Transfer of wall multiple times will result in waste of operational time hence the captain has to approach the Curator for any such request subject to approval.
- If any payment is pending no one in the stand will be allowed to participate and its sole responsibility of the captain to pay it.
- A stand will be only allocated if the group is ready with 2 or 3 artist and is ready to pay full amount.

19) The word Captain is not the owner of the stand but is the face of the group who will work under curation of the curator and will follow the instructions. Ownership remains in the hand of people paying for the wall and the decision to

display on the floor remains with the curator. If the curator is not happy or has complaints against the artist WAD can ban the artist and black list him / her for all future participation and can also stop them from exhibiting in the show.

20) Group participation is allowed only for the artist from a selected country hence Artist has to submit proof of their residences like an Emirates Id card or any other document as per their country.

21) Group participation is not allowed for artist residing in India, Iran, Singapore, Sri Lanka, Malaysia, South Korea, etc

22) Above mentioned rules are supposed to be followed by the group and will have to reply to the curator on email that they have noted all the points.

APPLICATION SELECTION

Selection

We strongly encourage applicants to apply with thoughtfully curated booth proposals and provide a strong and cohesive concept, which adds to the value of the art fair experience.

The Selection Committee reserves the right to approve Group Participation Applications. The Organiser also reserves the right to refuse works and, if appropriate, to remove any non-approved works of art from the Fair. All galleries will be informed of the Selection Committee's decision at the earliest opportunity upon receipt of the application.

Space Allocation

The Organiser will always consider the space and allocation requirements submitted, however kindly note that space options are subject to availability, a first-come, first-served basis and the overall curation criteria determined by the Organiser.

DISPLAY REGULATIONS

It is important that you review the set regulations, and agree to the following conditions prior to submitting your application to exhibit at World Art Dubai 2022.

- □ All artworks must be priced below the price ceiling of \$ 20,000 / AED 72,400 with 70% of the work displayed for sale below \$ 10,000 (AED 36,200). Artworks priced above \$ 20,000 / AED 72,400 must get approval from the Organiser. If approval is not sought prior to the show, we will not allow the art to be exhibited and you will be asked to remove it.
- □ All the artworks must be clearly tagged with full price in AED at the event. No discount should be stated on its displayed price tag. Any discount should be discussed discreetly between you and the prospective buyer.
- □ There should be minimum 15-20 cms (6-7 inches) space between each artwork hung on the wall. Exterior of the walls should be visible after installation of artwork. The show curators and show organizers reserve the right to ask you to remove art from the walls of the stand where it is deemed that there is not enough wall space visible.
- All artworks presented must be original. Reproductions of original artworks are not allowed. Limited editions of Sculptures and graphics must not exceed 25. Limited edition fine art photography must not exceed 150 editions, be signed and numbered, or accompanied by a certificate of authenticity, and the print is produced to a high standard.
- □ You are responsible of installing the artworks at the fair and must be completed 4 hours before the show opens. Installation assistance will be also available at a charge. Prior booking is required; please contact your salesperson for more information.
- □ Your stand must be curated and not look cluttered. The show curators and Organiser reserve the right to ask you to remove art from the walls of the stand where it is deemed that there is not enough wall space visible.
- □ A full catalogue of all the art being exhibited on your stand must be emailed to the Organiser minimum 6 weeks before the show opens with detailed artists bio and the contact details of each artist. Failure to comply will result in you not being included in the onsite fair catalogue.
- All artwork should be framed or mounted on walls or displayed on tables or plinths and be contained within the perimeters of your stand. No artwork can be displayed on the floor of the stand or left leaning against the walls of the stand.
- □ All artwork submitted must respect the local sensibility and customs in the UAE. No nudity or non-Islamic religion representation is allowed. If you are in any doubt about this, please contact the team.

Please note all successful applications will receive a contract for space with the payment schedule, and a signed contract with deposit payment is required to officially confirm your participation at World Art Dubai 2022

INTERNATIONAL FREIGHT

For importing works of art into UAE, legislation requirements include:

- Completion of import declaration which are processed by the UAE Customs Authority
- 5% duty on the CIF value of the work of the artworks

An Official Freight Handler has been appointed by the Organizer to facilitate importing of artworks on a temporary basis. Please however note that all duty and U.A.E. custom regulations are applicable once artwork has been sold.

It is also important to note that World Art Dubai staff <u>cannot accept or sign for any art that you ship directly to the</u> <u>venue. If you are not here to sign for your art it will be returned</u>. We strongly advise that you use our logistics partner, Al Naboodah, to avoid shipping delays and to avail of onsite logistic assistance.

EXHIBITORS INSURANCE

Mandatory Exhibitors Insurance of AED600 is charged to all exhibitors for Public Liability Cover. For insurance to protect your art from theft and accidental damage onsite and during transit, you are required to purchase your own policy. The Organiser cannot be held liable for any loss, theft or damage arising from your participation at the show. If in the unlikely event that art is stolen, please contact the onsite organiser office who will connect you directly with Dubai Police. 24hour stand security can be purchased, details are available in the Exhibitor Manual.



GROUP PARTICIPATION APPLICATION TERMS & CONDITIONS

GENERAL TERMS

The Organiser (Dubai World Trade Centre – **World Art Dubai**) sets the General Conditions, such as the venue, the duration, the dates,

the opening hours, and the ticket price of the $\ensuremath{\textbf{World}}\xspace$ and

if necessary reserves the right to modify them.

TERMS OF PARTICIPATION

The Organiser, with the help of a Selection Committee, will select all exhibitors for the show.

The Selection Committee, along with the Organiser, reviews all applications for the **World Art Dubai** and reserves the right to approve or not approve the Group Participation or artist.

The Committee and Organiser also reserve the right to refuse some of the proposed artists, and if these artists are exhibited during the fair, the Organiser reserves the right to remove any non-valid and unapproved artworks.

EXHIBITING CRITERIA

- · Exhibitors must be exclusively art galleries
- All work must be priced under <u>\$ 20,000 / AED 72,400. with</u> <u>70% of the work</u> displayed for sale below \$ 10,000 (AED 36,200)
- The full price must be shown next to the artwork
- A minimum of three artists must be shown on each Group Participation stand.
- An artist can be represented by <u>no more than 1 Group</u> <u>Participation</u>. Galleries wishing to exhibit the same artist should be in agreement
- All art must be original; colour reproductions of original work are not allowed

NOT PERMITTED AT WORLD ART DUBAI

- Offset lithographs
- Giclees (although we will allow giclees when the original work is created by computer i.e. digital art)
- Prints run off a commercial printing press using a transparency of an original work, even signed and dated by the artist, typically in editions of 150 or less

ALLOWED AT WORLD ART DUBAI

- Original prints made by hand by the artist (etchings, screen prints, mono prints, dry point, lithographs, mezzotint etc)
- Prints made with the artist's close involvement and supervision of the printing process; the artist to have made the plates; edition size normally no larger than 150
- Original, fine art photographic prints rather than commercial, mass-produced photographs are allowed. This means a high quality, controlled print process, usually overseen and authenticated by the photographer, in most cases signed and strictly limited

Sculptures:

• One-off pieces or editions of 25 or less.

CODE OF PRACTICE

The stand must be occupied by the exhibitor during the opening hours for the entire duration of the fair.

<u>Unless with prior agreement of the Organiser, it is prohibited</u> for an exhibitor to let, sublet or share a part of the stand.

Please note: we charge a flat fee to all exhibitors and do not take any sales commission towards the sale of artwork.
